WE SUPPORT

AI, CYBERSECURITY, & ASSET PROTECTION

- ADVOCATE FOR ETHICAL GUIDELINES AND ACCOUNTABILITY FRAMEWORKS IN AI DEVELOPMENT TO ENSURE RESPONSIBLE INNOVATION AND PREVENT MISUSE.
- ENFORCE ROBUST CYBERSECURITY STANDARDS AND FOSTER PUBLIC-PRIVATE PARTNERSHIPS TO PROTECT BUSINESSES AND CRITICAL INFRASTRUCTURE.
- STRENGTHEN INTELLECTUAL PROPERTY LAWS AND SECURE DIGITAL ASSET FRAMEWORKS TO SAFEGUARD INVESTMENTS AND INNOVATION.

AEROSPACE

- SUPPORT POLICIES AND FUNDING TO ENHANCE FLORIDA'S ROLE IN THE AEROSPACE INDUSTRY.
- ENCOURAGE INITIATIVES TO ATTRACT, RETAIN, AND GROW AEROSPACE BUSINESSES AND TALENT ACROSS THE STATE, PARTICULARLY ON THE SPACE COAST.

ATTAINABLE HOUSING

- BACK INCREASED INVESTMENT IN WORKFORCE HOUSING PROGRAMS, INCLUDING SHIP, SAIL, AND THE SADOWSKI TRUST FUND.
- MONITOR THE IMPLEMENTATION OF THE "LIVE LOCAL ACT."
- ADDRESS CONDOMINIUM AFFORDABILITY AND SPECIAL ASSESSMENTS IN FLORIDA BY SUPPORTING POLICIES THAT ENHANCE FINANCIAL TRANSPARENCY, PROVIDE RELIEF PROGRAMS, AND PROACTIVE MAINTENANCE TO EASE FINANCIAL BURDENS ON RESIDENTS WHILE ENSURING SAFE, ACCESSIBLE HOUSING.

CHILDCARE

- ADVOCATE FOR LEGISLATION EXPANDING ACCESS TO HIGH-QUALITY EARLY LEARNING AND CHILDCARE TO REDUCE STRAIN ON HOUSEHOLDS AND BUSINESSES.

ECONOMIC DEVELOPMENT

- COLLABORATE WITH FLORIDACOMMERCE AND KEY STAKEHOLDERS TO ADVANCE ECONOMIC DEVELOPMENT, INCLUDING BUSINESS INCENTIVES AND SUPPORT PROGRAMS.

EDUCATION

- PROMOTE EQUITABLE FUNDING AND STRATEGIES THAT ENHANCE EDUCATION QUALITY, AID BUSINESS RECRUITMENT, AND DEVELOP LOCAL TALENT FOR IN-DEMAND JOBS.

- SECURE FUNDING FOR INITIATIVES IMPROVING THE RESILIENCY OF THE INDIAN RIVER LAGOON, BEACHES, WATERWAYS, AND NATURAL HABITATS.

HEALTHCARE

The Chamber's Legislative Agenda is developed annually by the Government Affairs Committee and communicates the Chamber's positions on issues at the state level of government. Working together with partner organizations, the Chamber promotes public policy decisions that reflect the priorities of our region's economy. Chamber investors are encouraged to complete the Legislative Matrix form for submission to the Government Affairs Committee for consideration of inclusion in our Legislative Agenda.
